ORDER

**DISPOSITION: CERTIFICATE OF AUTHORITY CANCELED**

On March 1, 2008, Infotelecom, LLC was granted a certificate of authority to provide telecommunications service in Oregon as a competitive provider. *See* Order No. 08-146. Infotelecom, LLC had a previous certificate of authority, docket CP 1296, Order No. 05-1009, which was canceled for failure to pay revenue fees for 2005. *See* Order No. 06-492. The company filed a new application and received a new certificate of authority which is now being canceled.

Infotelecom LLC failed to pay the 3<sup>rd</sup> Quarter 2012 \$100 late statement fee to comply with Oregon Universal Service Fund requirements per ORS 759.425.

ORS 756.515(4) provides that the Commission may, after investigation, but without hearing, make such findings and orders as deemed justified by the results of the investigation. In view of the foregoing, the Commission determined at its March 12, 2013, Public Meeting that the certificate holder has failed to comply with Commission rules and terms of the certificate. The certificate of authority to provide telecommunications service should be canceled, per OAR 860-032-0008(2). The company is reminded that because it had a certificate of authority for one or more days during 2013, it is required to file an annual fee statement and pay a minimum of \$100 for that year.

The Commission notes that this is the second time it has canceled a certificate held by the certificate holder. Before the Commission will process any future application for certification, the certificate holder must fully comply with Commission rules. Any future application must include:

1. An explanation of why the company was unable to comply with the Commission rules;
2. Proof of payment of all outstanding revenue fees, including all applicable late fees, owed for each calendar year of operation as a certified telecommunications provider pursuant to ORS 756.310(4)(a), in accordance with Commission requirements;

3. Proof of compliance with Oregon Universal Service Fund (OUSF) requirements pursuant to ORS 759.425; and
4. Proof of filing of any outstanding annual reports pursuant to OAR 860-032-0060.

If the certificate holder fails to include these items with its application, the Commission will deem the application incomplete and deny it.

IT IS ORDERED that the certificate of authority held by Infotelecom, LLC is canceled.
