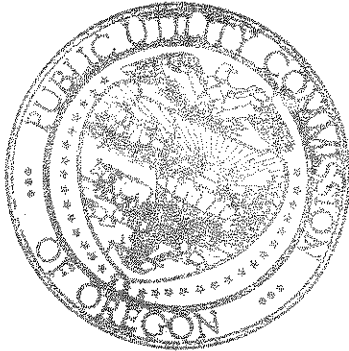

STAFF RECOMMENDATION:

Staff recommends the Commission approve Portland General Electric's (PGE or Company) request to waive the June 1 reconciliation report filing date requirement in OAR 860-038-00300(10).

DISCUSSION:

On May 31, 2013, PGE filed a request for a one-month extension of the filing date for its 2012 Electricity Product Claim Reconciliation Report. OAR 860-038-0300(10) requires that this report, which summarizes the purchases and sales of renewable energy certificates (RECs) for voluntary renewable programs, be filed by June 1, for the prior calendar year. The Company requested an additional month due to the absence of key personnel and unanticipated workload. Staff does not anticipate any adverse affects from the reporting delay.
