STAFF RECOMMENDATION:

Staff recommends that the Commission approve Northwest Natural's (NW Natural or Company) request and find that the Environmental Remediation Costs from April 1, 2014, through December 31, 2014, are prudent.

ISSUE:

NW Natural requests that the Commission issue an order finding environmental remediation costs incurred between April 1, 2014, and December 31, 2014, are prudent and are eligible for recovery under Commission Order No. 15-049.

APPLICABLE RULES AND LAWS:

NW Natural makes this filing in accordance with Order No. 15-049. In that order, the Commission determined that environmental remediation costs incurred on and after January 1, 2013, would be reviewed for prudence prior to becoming eligible for offset by insurance proceeds and amounts collected in base rates or amortization under the Site Remediation Recovery Mechanism (SRRM). To determine whether a cost was prudently incurred and recoverable in rates, "the Commission examines the objective reasonableness of a company's actions measured at the time the company acted."¹

ANALYSIS:

Background:

At the time this docket was filed, Staff determined that the prudence issue was best handled using a stipulation and supporting briefs. Staff used that process and had a stipulation and brief submitted to the Administrative Hearings Division (AHD) by October 6, 2015. Subsequently, Staff was informed by AHD that it had not used the appropriate method for handling a matter not docketed as a contested case and was told to submit the issue to the Commission via a Staff Memo.

Description:

NW Natural seeks to have its Environmental Remediation Costs from April 1, 2014, through December 31, 2014, declared prudent. As noted above, the Company, the Staff, and the Citizens' Utility Board (CUB) signed a stipulation agreeing that the Company's Environmental Remediation Costs from April 1, 2014, through December 31, 2014, were prudent.

Staff Analysis and Recommendation:

Staff has reviewed the costs and insurance proceeds reported by NW Natural for April 1, 2014, through December 31, 2014. Staff concludes the costs were objectively reasonable at the time NW Natural incurred them.

Staff recommends that the Commission find that that NW Natural's Environmental Remediation Costs from April 1, 2014, through December 31, 2014, are prudent.

PROPOSED COMMISSION MOTION:

Northwest Natural's request that the Environmental Remediation Costs from April 1, 2014, through December 31, 2014, are prudent, be approved.
