DISPOSITION: COMPLAINT DENIED FOR LACK OF JURISDICTION

On February 24, 2016, B. A. filed a complaint against Verizon Wireless Services, LLC, and Verizon Wireless (VAW), LLC, (collectively Verizon Wireless). Complainant challenges late payment fees charged by Verizon Wireless.

On our own motion, we deny the complaint for lack of jurisdiction. This agency has the authority to regulate telecommunication services within Oregon. The statutes providing us that authority, however, explicitly exclude from our oversight services provided by radio common carrier, which include cellular communications services.

Accordingly, we have no jurisdiction over the cellular services provided by Verizon Wireless. The complaint must be denied.<sup>5</sup>

A. notes that he sent the Commission's Consumer Services Division a letter about this matter on February 3, 2016, and complains that he had not yet received a response as of February 24, 2016. Our records show that the Consumer Services Division received his letter on February 5 and sent an inquiry to Verizon Wireless on February 8. After obtaining additional information from Verizon Wireless, the Consumer Services Section left a voice mail message with B. A. on February 17, then sent him a letter on February 23 stating that the Commission lacked jurisdiction and recommending that he contact the Consumer Protection Division of the Oregon Department of Justice.
