ORDER

DISPOSITION: CHARGES ASSESSED

The Public Utility Commission of Oregon (Commission) has designated its files on the subject of this matter as the record in this case. Based on information contained in those files, the Commission makes the following:

## FINDINGS OF FACT

TOTAL CALL MOBILE INC is a telecommunications provider required to submit monthly Residential Service Protection Fund (RSPF) surcharge remittance reports and payments to the Commission. See OAR 860-033-0006.

TOTAL CALL MOBILE INC failed to meet all or part of the requirements specified above by the due date(s) as follows: the January 2016 RSPF Surcharge Remittance Form and payment were due on February 22, 2016, and has not been received.

The Commission served a Notice of Proposed Assessment on TOTAL CALL MOBILE INC on March 10, 2016. TOTAL CALL MOBILE INC did not respond.

Pursuant to OAR 860-033-0006 and OAR 860-001-0050, the Commission finds that TOTAL CALL MOBILE INC owes \$100.08 which may include any or all of the following charges: RSPF surcharge remittance(s), late payment penalties, interest (calculated to the date of this Order), and late report fee(s) for January 2016. Please note that specific amounts for each assessed charge are not included in this Order to protect the confidentiality of TOTAL CALL MOBILE INC underlying records. For an itemization of the specific amount for each assessed charge, the provider may contact Frank Lackey at <a href="mailto:frank.lackey@state.or.us">frank.lackey@state.or.us</a>, (503) 378-4927.

Where applicable, the interest amount is calculated as of the date of this Order. Interest will continue to accrue at 9 percent per annum until the Commission receives full payment. See OAR 860-033-0006(7).

### Conclusions

TOTAL CALL MOBILE INC failed to meet its filing obligations required by law. The amount set forth above should be assessed, with the exception that any applicable interest will continue to accrue at 9 percent per annum until the Commission receives full payment.

- 1. \$100.08 is assessed against TOTAL CALL MOBILE INC and is due and payable by 5:00 p.m. on the 10<sup>th</sup> day after the service date of this order to the Oregon Public Utility Commission, Residential Service Protection Fund, PO Box 2153, Salem OR 97308-2153, or online at http://apps.rspf.org.
- 2. Where applicable, interest will continue to accrue at 9 percent per annum until the Commission receives full payment.
