ORDER

DISPOSITION: CERTIFICATE OF AUTHORITY CANCELED

On July 21, 1997, Net One International, Inc. (Net One) was granted a certificate of authority to provide telecommunications service in Oregon as a competitive provider. See Order No. 97-273.

Net One has failed to comply with Oregon Universal Service Fund (OUSF) requirements for 4th Quarter 2015 and 2nd Quarter 2016 per ORS 759.425 and OAR 860-032-0610 through 860-032-0660.

Net One also failed to comply with annual fee requirements for 2015 per ORS 756.310 and OAR 860-032-0095.

Commission staff has made numerous attempts to notify Net One of the delinquencies and potential cancellation. Net One failed to respond.

ORS 756.515(4) provides that the Commission may, after investigation, but without hearing, make such findings and orders as deemed justified by the results of the investigation. In view of the foregoing, the Commission determined at its September 27, 2016, Public Meeting that Net One has failed to comply with Commission rules and terms of the certificate. The certificate of authority to provide telecommunications service should be canceled, per OAR 860-032-0008(2). Net One is reminded that because it had a certificate of authority for one or more days during 2016, it is required to file an annual fee statement and pay a minimum of \$100 for that year.

The Commission notes that this is the second time it has canceled a certificate held by Net One. Before the Commission will process any future application for certification, Net One must fully comply with Commission rules. Any future application must include, as applicable:

1. An explanation of why the company was unable to comply with Commission rules;

- 2. Proof of payment of all outstanding revenue fees, including late payment fees, owed for each calendar year of operation pursuant to ORS 756.310(4)(a) and OAR 860-032-0095, in accordance with Commission requirements;
- 3. Proof of compliance with OUSF requirements pursuant to ORS 759.425 and OAR 860-032-0610 through 860-032-0660;
- 4. Proof of filing of any outstanding annual reports pursuant to OAR 860-032-0060; and
- 5. Proof of compliance with Residential Service Protection Fund (RSPF) requirements pursuant to ORS chapter 290, section 7, Oregon Laws 1987, and OAR 860-033-0006.

If Net One fails to include these items with its application, the Commission will deem the application incomplete.

IT IS ORDERED that the certificate of authority held by Net One International, Inc. is canceled.

A party may appeal this order by filing a petition for review with the Court of Appeals in compliance with ORS 183.480 through 183.484.
