DISPOSITION: STIPULATION ADOPTED

In this order, the Public Utility Commission of Oregon adopts a stipulation between the Commission Staff and defendant and imposes civil monetary penalties under the terms and conditions of the stipulation.

I. COMPLAINT AND STIPULATION

On March 31, 2017, the Commission filed a complaint against defendant. The complaint charged defendant with one violation of law, OAR 952-001-0090(2)(c), and requested a penalty of \$1,000. On March 31, 2017, a copy of the complaint was served.

On April 4, 2017, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, defendant:

- (1) Admits committing the alleged violation and agrees that the Commission may enter an order assessing civil monetary penalties;
- (2) Agrees to complete, within 45 days following the entry of a final order, a training session with the Oregon Utility Notification Center Speakers Bureau

- on Oregon excavation laws and with Cascade Natural Gas on operator safety;
- (3) To submit completed Training Verification forms for all required trainings to the Commission within 10 days of the date of the last training and no later than 55 days following the entry of this order.

The parties further agree that a portion of the penalties should be suspended, unless defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center under ORS 757.552 for a period of one year following the date of the Commission's final order in these proceedings.

II. DISCUSSION

The stipulation is adopted. Under the terms of the stipulation, the allegations of the complaint are true, and defendant has violated the Oregon Administrative Rule as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

III. ORDER

IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties are assessed against Millsite Management Company dba Millsite Landscape Services in the amount of \$1,000 for one violation of law.
- 3. Defendant must pay the sum of \$200, due and payable within 30 days from the date of entry of this order. Payment must be in the form of a cashier's check or money order made out to the **Public Utility**Commission of Oregon, and the memo line of the cashier's check or money order shall state the "NC 360" docket number in the caption of this order. (Mail payment to: Public Utility Commission of Oregon, PO Box 2153, Salem, OR 97308).

4. Defendant must:

(a) Timely complete a training session with the Oregon Utility
Notification Center Speakers Bureau. Defendant will contact the
OUNC Speakers Bureau to arrange for and have all employees that
perform excavation work to attend a training session on Oregon
excavation laws within 45 days of the entry of this order;

- (b) Timely complete a training session with Cascade Natural Gas on operator safety. Defendant will contact Cascade Natural Gas to arrange for, and have all employees that perform excavation work attend a training session on operator safety within 45 days of the entry of this order; and
- (c) File completed Training Verification forms for all required training to the Public Utility Commission of Oregon at the address indicated on the form within 10 days of the date of the last training session and no later than 55 days of the entry of this order.
- 5. Payment of the balance of the penalties \$800 will be suspended, unless defendant fails to comply with any term of the stipulation. If the defendant has not met the requirements and time periods set forth in paragraphs 3 and 4 above, the unpaid balance of the amount assessed in paragraph 2 will be due immediately following the expiration of the time periods.
