DISPOSITION: STIPULATION ADOPTED

On May 26, 2017, the Public Utility Commission of Oregon filed a complaint against defendant. The complaint charged defendant with one violation of law, OAR 952-001-0090(1), and requested a penalty of \$1,000. On May 26, 2017, a copy of the complaint was served.

On June 1, 2017, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, defendant admits committing the alleged violation and agrees that the Commission may enter an order assessing civil monetary penalties. Defendant also agrees to complete, within 45 days following the entry of a final order, a training session with the Emerald People's Utility District on electric overhead and underground safety. A review of the Commission's records indicates that defendant has completed the training session on operator safety.

The parties further agree that the penalties should be suspended, unless defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center under ORS 757.552 for a period of one year following the date of the Commission's final order in these proceedings.

The stipulation is adopted. From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and defendant has violated Oregon Administrative Rules as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

#### **ORDER**

#### IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against Queen of Spades Utilities, Inc. in the amount of \$1,000 for one violation of law.
- 3. Payment of the penalties (\$1,000) shall be suspended, unless a showing is made that defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center.

3	monetary p	penalty against Defendant in the amount of \$1,000 under the following terms and
4	conditions	· :
5	A.	Defendant must sign and return this Stipulation within 20 days of the date it was
6		served upon (mailed to) Defendant.
7	B.	Payment of the penalty (\$1,000) will be suspended and no further penalties will be
8		imposed for the violation alleged in the Complaint unless Defendant fails to comply
9		with all of the terms of this Stipulation and all of the rules adopted by the Oregon
10		Utility Notification Center (OUNC) under ORS 757.552 for a one-year period
11		following the date of the Commission's entry of an order.
12	C.	Defendant must contact the Emerald People's Utility District (EPUD), Chris Miles,
13		by email at ChrisM@epud.org or by calling (541) 744-7481 to arrange for and ensure
14		that all of defendant's employees that engage in excavation activity in Oregon as part
15		of their job duties attend an EPUD-provided training session on electric overhead and
16		underground safety within 45 days following the entry of a final order.
17	D.	Defendant must take a blank copy of the Training Verification form attached to this
18		Stipulation as Attachment 1 to all required trainings scheduled under paragraph 4.C.
19		above. Defendant must ensure that all of its employees attending a required training
20		sign a Training Verification form to verify attendance. A representative of the
21		organization providing the training (Instructor) must sign the Training Verification
22		form to verify each person listed on the form completed the training. Defendant must
23		return all completed Training Verification forms to Complainant at the address on the
24		Form within 10 days of the date of the last training session and in no event later than
25		55 days following the date of the Commission's entry of an order in this docket.

2	the terms of this Stipulation and all OUNC rules for that one-year period,

4	portion of the suspended penalties. In such case, Defendant is entitled to a hearing		
5	and to be notified of the basis upon which Complainant contends that compliance has		
6	not occurred.		
7	F. Complainant's failure to enforce any provision of this Stipulation, or decision to		
8	waive any violation or nonperformance of this Stipulation in one instance, will not		
9	constitute a waiver by the Complainant of that provision, any other provision, or any		
0	other violation or nonperformance in another instance.

13	the Stipulation is not accepted in its entirety, it is deemed withdrawn.
