DISPOSITION: STIPULATION ADOPTED

On September 15, 2017, the Public Utility Commission of Oregon filed a complaint against defendant. The complaint charged defendant with one violation of law, OAR 952-001-0080 and requested a penalty of \$2,000. On September 15, 2017, a copy of the complaint was served.

On October 10, 2017, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, defendant admits that the violation was committed as alleged in the Complaint and agrees that the Commission may enter an order assessing civil monetary penalties. Defendant contends that the violation was the result of actions by a third party contractor, but accepts responsibility for payment of the fine as an operator subject to OAR 952-001-0080.

The parties further agree that the penalties should be suspended, unless defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center under ORS 757.552 for a period of one year following the date of the Commission's final order in these proceedings.

The stipulation is adopted. From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and defendant has violated Oregon Administrative Rule as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

ORDER

IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against Frontier Communications in the amount of \$2,000 for one violation of law.
- 3. Payment of the balance of the penalties (\$2,000) shall be suspended, unless a showing is made that defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center.

3	monetary penalties against the Defendant in the amount of \$2,000 under the following terms and	
4	conditions:	
5	A. Defendant shall sign and return this Stipulation within 20 days of the date it was served	
6	upon (mailed to) Defendant.	
7	B. Payment of the penalties (\$2,000) is suspended and the penalties shall be waived with no	
8	further penalties imposed for the violation alleged in the Complaint unless Defendant	
9	fails to comply with all of the terms of this Stipulation and all of the rules adopted by the	
10	Oregon Utility Notification Center (OUNC) under ORS 757.552 for a one-year period	
11	following the date of the Commission's entry of an order.	
12	C. In the event that complainant contends that the Defendant has not complied with all of	
13	the terms of this Stipulation and all OUNC rules for that one year period, complainant	
14	may reopen this proceeding and petition for imposition of all or a portion of the	
15	suspended penalties. In such case Defendant shall be entitled to a hearing and to be	
16	notified of the basis upon which complainant contends that compliance has not occurred.

18	This Stipulation is conditioned upon final approval of its terms by the Commission. If	
19	the Stipulation is not accepted in its entirety, it shall be deemed withdrawn.
