DISPOSITION: STIPULATION ADOPTED

On October 13, 2017, the Public Utility Commission of Oregon filed a complaint against defendant. The complaint charged defendant with one violation of law, OAR 952-001-0080. Defendant committed the violation described in this complaint within one year from the date a prior order was issued. *See* Order No. 17-110. A penalty shall be imposed in the amount of \$5,000 for the violation alleged, and the \$4,000 penalty that was suspended in Order No. 17-110 entered against defendant shall be reinstated, for a total penalty of \$9,000. On October 13, 2017, a copy of the complaint was served.

On October 31, 2017, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, defendant admits committing the alleged violation and agrees that the Commission may enter an order assessing civil monetary penalties.

The parties further agree that a portion of the penalties should be suspended, unless defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center under ORS 757.552 for a period of one year following the date of the Commission's final order in these proceedings.

The stipulation is adopted. From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and Defendant has violated the Oregon Administrative Rule as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

ORDER

IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against CENTURYLINK COMMUNICATIONS, LLC, in the total amount of \$9,000, for one new violation of law (\$5,000), and the balance of the penalties (\$4,000) which is reinstated from Order No. 17-110 entered against defendant.
- 3. Defendant shall pay the sum of \$4,000, due and payable within 30 days from the date of service of this order.
- 4. Payment of the balance of the penalties (\$5,000) shall be suspended, unless a showing is made that defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center.

2	The parties further agree that the Commission may enter an order assessing civil
3	monetary penalties against the Defendant in the amount of \$5,000 under the following terms and
4	conditions:
5	A. Defendant shall sign and return this Stipulation within 20 days of the date it was served
6	upon (mailed to) Defendant.
7	B. A suspended civil penalty in the amount of \$4,000 is imposed per Order 17-110 (NC 356)
8	and must be paid.
9	C. Payment of the penalty imposed under paragraph 4, \$5,000 is suspended and the penalty
10	shall be waived with no further penalties imposed for the violation alleged in the
11	Complaint unless Defendant fails to comply with all of the terms of this Stipulation and
12	all of the rules adopted by the Oregon Utility Notification Center (OUNC) under ORS
13	757.552 for a one-year period following the date of the Commission's entry of an order.
14	D. In the event that Complainant contends that Defendant has not complied with all of the
15	terms of this Stipulation and all OUNC rules for that one-year period, Complainant may
16	reopen this proceeding and petition for imposition of all or a portion of the suspended
17	penalties. In such case, Defendant shall be entitled to a notice and hearing on the basis
18	upon which Complainant contends that compliance has not occurred.
19	E. Complainant's failure to enforce any provision of this Stipulation, or decision to waive
20	any violation or nonperformance of this Stipulation in one instance, will not constitute a
21	waiver by the Complainant of that provision, any other provision, or any other violation
22	or nonperformance in another instance.
