ORDER

DISPOSITION: CHARGES ASSESSED

In this order, the Public Utility Commission of Oregon assesses \$100.99 against BOSS VENTURES LLC for failure to make required remittances. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

FINDINGS OF FACT

BOSS VENTURES LLC is a telecommunications provider required to submit monthly Residential Service Protection Fund (RSPF) surcharge remittance reports and payments to the Commission.¹ These amounts can include any or all of the following: RSPF surcharge remittance(s), late payment penalties, interest (calculated to the date of this Order), and late report fee(s) for March 2018².

BOSS VENTURES LLC failed to meet all or part of the requirements specified above by the due date(s) as follows: the March 2018 RSPF Surcharge Remittance Form and Payment were due on April 23, 2018, and have not been received.

The Commission served a Notice of Proposed Assessment on May 10, 2018 on BOSS VENTURES LLC did not respond with full payment, and all current amounts owing have not been paid.

CONCLUSIONS

BOSS VENTURES LLC failed to meet its filing obligations required by law. BOSS VENTURES LLC owes the current balance of \$100.99. These charges are for March 2018.

The amount set forth above should be assessed, with the applicable interest to accrue at 9 percent per annum until the Commission receives full payment.³ Please note that

- 2. Where applicable, interest will continue to accrue at 9 percent per annum until the Commission receives full payment.
