DISPOSITION: STIPULATION ADOPTED

On September 6, 2018, the Public Utility Commission of Oregon filed a complaint against defendant. The complaint charged defendant with a violation of law, OAR 952-001-0070(1). Defendant committed the violation described in this complaint within one year from the date a prior order was issued. *See* Order No. 17-460. A penalty shall be imposed in the amount of \$5,000 for the violation alleged, and the \$2,000 penalty that was suspended in Order No. 17-460 entered against defendant shall be reinstated, for a total penalty of \$7,000. On September 6, 2018, a copy of the complaint was served.

On September 11, 2018, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Defendant admits committing the violation alleged in the complaint. The stipulation is adopted.

From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and defendant has violated Oregon Administrative Rule as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

ORDER

IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against Comcast Cable Communications Management, LLC in the total amount of \$7,000, for a new violation of law (\$5,000), and the balance of the penalties (\$2,000) which is reinstated from Order No. 17-460 entered against defendant.
- 3. Defendant shall pay the sum of \$7,000, due and payable within 30 days from the date of service of this order. The Commission acknowledges receipt of the amount of \$7,000 from defendant on September 27, 2018.

A party may request rehearing or reconsideration of this order under ORS 756.561. A request for rehearing or reconsideration must be filed with the Commission within 60 days of the date of service of this order. The request must comply with the requirements in OAR 860-001-0720. A party may appeal this order by filing a petition for review with the Court of Appeals in compliance with ORS 183.480 through 183.484.
