DISPOSITION: STIPULATION ADOPTED

On December 5, 2018, the Public Utility Commission of Oregon filed a complaint against defendant. The complaint charged defendant with one violation of law, OAR 952-001-0070(1) and requested a penalty of \$1,000. On December 5, 2018, a copy of the complaint was served.

On December 10, 2018, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, defendant admits that the violation was committed as alleged in the Complaint and agrees that the Commission may enter an order assessing civil monetary penalties. Defendant contends that the violation was the result of actions by a third party contractor, but accepts responsibility for payment of the fine as an operator subject to OAR 952-001-0070. Defendant also agrees to provide the Commission with a plan or procedure (policy) that identifies the company's workflow process for marking underground facilities, and investigating and troubleshooting damages to underground facilities, within 60 days following the entry of a final order.

The parties further agree that the penalties should be suspended, unless defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center under ORS 757.552 for a period of one year following the date of the Commission's final order in these proceedings.

The stipulation is adopted. From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and defendant has violated Oregon Administrative Rule as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

## **ORDER**

## IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against Frontier Communications Northwest, Inc., in the amount of \$1,000 for one violation of law.
- 3. Payment of the balance of the penalties (\$1,000) shall be suspended, unless:
  - (a) A showing is made that defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center; or
  - (b) Defendant fails to timely provide the Commission with a plan or procedure (policy) that identifies the company's workflow process for marking underground facilities, and investigating and troubleshooting damages to underground facilities within 60 days following the entry of this order. The policy must include but is not limited to the following:
    - 1) Description of the purpose of the policy and commitment thereof by leadership, management, and employees;
    - 2) Identification of notifications and types of responses for marking underground facilities;
    - 3) Identification of tasks assigned to participants by title or position and their roles and responsibilities in the workflow process;
    - Identification of the technology or systems and methods used throughout the policy that enables the completion of identified tasks; and
    - 5) Criteria for periodic review of the effectiveness and identification of best practices.

4. If defendant has not timely provided the Commission with a plan or procedure (policy) that identifies the company's workflow process for marking underground facilities, investigating and troubleshooting damages to underground facilities within 60 days following the entry of this order, the Complainant may reopen this proceeding and petition for imposition of all or a portion of the suspended penalty.

3	monetary penalty against Defendant in the amount of \$1,000 under the following terms and

5	A. Defendant must sign and return this Stipulation within 20 days of the date it was
6	served upon (mailed to) Defendant.
7	B. Payment of a civil penalty (\$1,000) is suspended and the penalty shall be waived with
8	no further penalties imposed for the violation alleged in the Complaint unless
9	Defendant fails to comply with all of the terms of this Stipulation and all of the rules
10	adopted by the Oregon Utility Notification Center (OUNC) under ORS 757.552 for a
11	one-year period following the date of the Commission's entry of an order.

4	portion of the suspended penalty. In such case, Defendant shall be entitled to a
5	hearing and to be notified of the basis upon which Complainant contends that
6	compliance has not occurred.
7	E. Complainant's failure to enforce any provision of this Stipulation, or decision to
8	waive any violation or nonperformance of this Stipulation in one instance, will not
9	constitute a waiver by the Complainant of that provision, any other provision, or any
10	other violation or nonperformance in another instance.

12	This Stipulation is conditioned upon final approval of its terms by the Commission. If
13	the Stipulation is not accepted in its entirety, it is deemed withdrawn.
