## DISPOSITION: MOTION GRANTED; WITHDRAWAL OF ADVICE NO. 19-36 ACKNOWLEDGED; DOCKET NO. UE 372 CLOSED

In Order No. 20-279, the Commission adopted an all-party stipulation relating to the consolidated dockets UE 370 and UE 372, which resolved all of the contested issues in docket UE 372. The stipulation provided, at paragraph 2, that PGE would withdraw its request under Schedule 122 in docket UE 372.

Order No. 20-279, in part, states that:

2. Portland General Electric Company shall file a motion to dismiss and a notice of withdrawal of Advice No. 19-36 for Renewable Resource Automatic Adjustment Clause (Schedule 122) in Docket No. UE 372 on or before August 28, 2020.

In accordance with that order, on August 28, 2020, PGE filed a Notice of Withdrawal of Advice No. 19-36 and Motion to Dismiss. The motion withdraws Advice No. 19-36 and moves to dismiss the projects addressed in that advice from consideration in this consolidated docket.

Oregon Administrative Rule 860-001-0090(1)(g) provides that the Commission delegates to the administrative law judge authority to decide procedural matters, but not to grant contested motions to dismiss or other contested motions that involve final determination of the proceedings. PGE states that its motion is supported by the Commission Staff, the Oregon Citizens' Utility Board, and the Alliance of Western Energy Consumers. As these constitute all of the parties in these proceedings, the motion is therefore uncontested and may be granted pursuant to delegated authority.

I find that the motion and notice filed by PGE comply with Order No. 20-279 and should be granted.

### ORDER

### IT IS ORDERED that:

- 1. The Notice of Withdrawal of Advice No. 19-36 for Renewable Resource Automatic Adjustment Clause (Schedule 122) in Docket No. UE 372 is hereby acknowledged.
- 2. The Motion to Dismiss filed by Portland General Electric Company is granted.
- 3. Docket No. UE 372 is closed.
