**ORDER** 

Request to Extend Partial Waiver of OAR 860-021-0130(2), Meter Testing.

DISPOSITION: TIME LINE SPECIFIED IN ORDER NO. 20-210 AMENDED

On July 6, 2020, the Commission issued Order No. 20-210, adopting a Staff recommendation, approving Northwest Natural Gas Corporation, dba NW Natural's partial waiver request of OAR 860-021-0130(2) for a period of six months, commencing July 6, 2020. This rule relates to meter tests, specifying, "A customer and/or a designated representative shall have the right to be present at any meter test. The test shall be conducted at a mutually acceptable time during regular business hours."

NW Natural filed an application requesting a partial waiver of OAR 860-021-0130(2) due to the COVID-19 public health emergency. NW Natural requested a waiver of the first sentence of this rule relating to a customer's right to be present at any meter test. The Commission approved this request, and extended the applicability of the waiver through Order No. 20-210.

On December 23, 2020 NW Natural filed a motion to amend Order No. 20-210 to extend the temporary partial waiver of OAR 860-021-0120(2) an additional 9 months, which would result in the waiver expiring on October 6, 2021. NW Natural asserts there is good cause to approve this motion given the continuing COVID-19 public health emergency.

The Chief Administrative Law Judge has been delegated the authority to modify time lines specified in a Commission order. Exercising that authority, I amend Order No. 20-210 to change expiration of the rule waiver from January 6, 2021 to October 6, 2021.
