Implementation of House Bill 2475.

DISPOSITION: MOTION TO DESIGNATE PROCEEDING AS ELIGIBLE FOR

HB 2475 FUNDS GRANTED, PROPOSED BUDGET FOR HB 2475

GRANT APPROVED

On July 27, 2022, Community Energy Project (CEP) filed a notice of participation and request for House Bill (HB) 2475 funding and a proposed budget in docket UM 2211. No response to the filing was made. CEP's proposed budget shows eligible expenses of \$14,450, and it seeks an HB 2475 Funding Grant of \$14,450. I grant the request of CEP, and its proposed budget is approved.

The Commission Approved Form of Interim Funding Agreement in Order No. 22-043 defines "Eligible Dockets" as a proceeding before the Commission to review:

- 1. Non-complaint contested cases, rulemakings, and non-contested dockets that affect the applicable utility and its low-income residential customers and environmental justice communities,
- 2. Named, non-docketed Commission led processes addressing issues that affect the applicable utility and its low-income residential customers and environmental justice communities, or
- 3. An Integrated Resource Plan.

Investor-owned utilities (IOUs) Portland General Electric Company (PGE); PacifiCorp, dba Pacific Power; Northwest Natural Gas Company, dba NW Natural;, Avista Corporation, dba Avista Utilities; Idaho Power Company; and Cascade Natural Gas Corporation are directly affected by docket UM 2211. This docket involves the implementation of HB 2475, and CEP claims this proceeding will have a substantial

impact on their energy burdened clients living in Portland. In addition, CEP serves low-income residential customers and environmental justice communities, including seniors, people with disabilities, women, people of color, and other historically marginalized groups. CEP asserts their clients will benefit from CEP's involvement in the proceeding as IOUs create energy burden relief programs.

CEP asserts that it is eligible for funding because it is a pre-certified eligible organization pursuant to Commission Order No. 22-043. CEP argues that it primarily serves Portland and Multnomah County utility customers that are disproportionately energy burdened, including low-income residential customers and environmental justice communities, through safety repairs and efficiency upgrades, among other things, directly to clients' homes.

I agree that CEP qualifies as an eligible organization under Order No. 22-043. I find that docket UM 2211 qualifies as an eligible proceeding because the proceeding is anticipated to have a substantial impact on utilities' low-income residential customers and environmental justice communities as it implements the directives of HB 2475. Accordingly, the motion should be granted and this docket certified as an eligible proceeding.

The Interim Agreements for HB 2475 Intervenor Funding, approved by the Commission in Order No. 22-043, provides that pre-certified intervenors must submit a proposed HB 2475 Grant Funds budget to the Commission that contains, at a minimum, the following information:

- 1. A statement of work to be performed by the Recipient for which the Recipient is seeking funding;
- 2. A description of the areas to be investigated and addressed by Recipient;
- 3. A budget showing estimated attorney fees, which may include the cost for appropriate support staff and operational support; and
- 4. A budget showing estimated consultant fees and expert witness fees, which may include the cost for appropriate support staff and operational support.

Once a proposed budget is received, the Commission decides whether HB 2475 Grant Funds are available for use based on factors identified in the Interim Agreements for HB 2475 Intervenor Funding. The Commission has the authority to accept, deny, or partially deny the request, and may place reasonable conditions on the grant, and may

delegate this responsibility to the Chief Administrative Law Judge, consistent with Order No. 21-213.

CEP's proposed budget includes the requisite information and reflects the current schedule adopted in this docket.

In light of the issues being addressed, the complexity of the issues and the significant policy decisions to be made, CEP's proposed budget is reasonable and should be approved.

ORDER

IT IS ORDERED that:

- 1. This proceeding is designated as a proceeding eligible for HB 2475 Funds.
- 2. Community Energy Project is certified to receive funds in this docket.
- 3. Community Energy Project's proposed budget for an HB 2475 Funding Grant is approved.
- 4. An HB 2475 Funding Grant is approved up to \$14,450 for activity in docket UM 2211.
- 5. When the Community Energy Project submits a request for payment, it must indicate in that request activity by the matters and utilities referenced in its request for HB 2475 Funding Grand and Proposed Budget.
