ORDER

## DISPOSITION: \$206.00 CHARGES ASSESSED

In this order, the Public Utility Commission assesses $\$ \mathbf{2 0 6 . 0 0}$ against AMERICA NET LLC for failure to make required payments. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

## FINDINGS OF FACT

AMERICA NET LLC is a telecommunications provider required to submit an annual gross revenue fee statement and fee payment to the Commission. ${ }^{1}$ These amounts can include the outstanding annual fee; a late statement fee, ${ }^{2}$ and late payment penalty. ${ }^{3}$

AMERICA NET LLC failed to submit the statement and payment by the due date of April 1, $2023 .{ }^{4}$

The Commission sent a Proposed Order to AMERICA NET LLC on 6/7/2023. AMERICA NET LLC did not respond with full payment, and all current amounts owing have not been paid.

## CONCLUSIONS

AMERICA NET LLC failed to provide an annual gross revenue statement and fee payment required by law. AMERICA NET LLC owes the current balance of $\$ \mathbf{2 0 6 . 0 0}$.

The amount set forth above should be assessed with the applicable late payment penalty to accrue at 2 percent per month on the balance of the annual fee due until the Commission receives full payment. For a current payment amount, please contact

Holly Healey at (971) 239-6280 or holly.healey@puc.oregon.gov. Failure to comply with the terms of this order may result in the Commission suspending or cancelling the telecommunications provider's Certificate of Authority to provide telecommunications service in Oregon. ${ }^{5}$

## ORDER

IT IS ORDERED that:

1. AMERICA NET LLC is assessed $\mathbf{\$ 2 0 6 . 0 0}$ immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
2. Where applicable, the late payment penalty will continue to accrue at 2 percent per month until the Commission receives full payment.
3. Under ORS 293.231, the Commission must refer your account to the Department of Revenue or a private collection firm if it receives no payment on the amount due and payable in this Order by the due date of $\mathbf{9 / 7 / 2 0 2 3}$, which is ninety days from its 6/7/2023 origination date. Non payment will result in a minimum 20\% collection fee added to the amount you owe.

A party may request rehearing or reconsideration of this order under ORS 756.561. A request for rehearing or reconsideration must be filed with the Commission within 60 days of the date of service of this order. The request must comply with the requirements in OAR 860-001-0720. A copy of the request must also be served on each party to the proceedings as provided in OAR 860-001-0180(2). A party may appeal this order by filing a petition for review with the Court of Appeals in compliance with ORS 183.480 through 183.484.
