ORDER

DISPOSITION: \$139.88 CHARGES ASSESSED

In this order, the Public Utility Commission of Oregon assesses **\$139.88** against DIAL LONG DISTANCE INC for failure to make required payments. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

FINDINGS OF FACT

DIAL LONG DISTANCE INC is a telecommunications provider required to submit quarterly contribution worksheets and payments to the Commission for the Oregon Universal Service Fund (OUSF).¹ These amounts can include any or all of the following: contribution payment(s), late payment penalty(ies), interest and late statement fee(s), including any portion due but not paid for the period(s).²

DIAL LONG DISTANCE INC failed to meet these requirements by failing to Q1 OUSF 2023 fees.³

The Commission sent a Proposed Order to DIAL LONG DISTANCE INC on 7/10/2023. DIAL LONG DISTANCE INC did not respond with full payment, and all current amounts owing have not been paid.

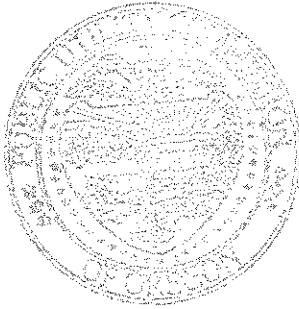

ORDER

IT IS ORDERED that:

1. DIAL LONG DISTANCE INC is assessed **\$139.88** immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
2. Where applicable, interest will continue to accrue at 9% per annum until the Commission receives full contribution payment.
3. Under ORS 293.231, the Commission must refer your account to the Department of Revenue or a private collection firm if it receives no payment on the amount due and payable in this Order by the due date of **10/11/2023**, which is ninety days from its **7/10/2023** origination date. Non payment will result in a minimum 20% collection fee added to the amount you owe.
