## **STAFF RECOMMENDATION:**

Staff recommends the Commission approve PacifiCorp's (PacifiCorp, PAC, or Company) request for a partial waiver of OAR 860-027-0070(1) and extend the Annual Report Deadline for 2024 until May 31, 2024.

#### DISCUSSION:

#### ssue

Whether the Commission should approve PacifiCorp's request for a limited waiver of OAR 860-027-0070(1) and extend the Annual Report deadline for 2024 from May 1, 2024, to May 31, 2024.

#### Applicable Rule or Law

OAR 860-027-0070(1) requires all electric, gas, water, and steam heat utilities to submit their Annual Report, also known as the Oregon FERC Form 1 Supplement, by May 1 of each year.

Under OAR 860-027-0000(2), the Commission can grant waivers of Division 27 rules for good cause shown. A request for a waiver must be made in writing, unless otherwise allowed by the Commission.

#### <u>Analysis</u>

On January 12, 2024, PacifiCorp submitted a waiver under the UM 1631 docket to extend the deadline to file its annual report until May 31, 2024. In its application, the Company states that it has regularly requested this waiver and has received extensions from the Commission since 2010.

The Company notes that the waiver is necessary to process all the required data from each of the state jurisdictions in which it operates.

Staff finds that approving PacifiCorp's waiver request is consistent with the Commission's past actions. See, e.g., Order Nos. 22-089, 20-140, and 19-152.

#### **Conclusion**

Staff recommends the Commission approve PacifiCorp's request for a partial waiver of OAR 860-027-0070(1) and extend its Annual Report deadline until May 31, 2024.

The Company has reviewed a draft of this memo and agrees with its content.
