ORDER

DISPOSITION: \$206.00 CHARGES ASSESSED

In this order, the Public Utility Commission assesses **\$206.00** against TECHNOLOGY SERVICES INC for failure to make required payments. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

FINDINGS OF FACT

TECHNOLOGY SERVICES INC is a telecommunications provider required to submit an annual gross revenue fee statement and fee payment to the Commission.¹ These amounts can include the outstanding annual fee; a late statement fee,² and late payment penalty.³

TECHNOLOGY SERVICES INC failed to submit the statement and payment by the due date of April 1, 2024.⁴

The Commission sent a Proposed Order to TECHNOLOGY SERVICES INC on 6/5/2024. TECHNOLOGY SERVICES INC did not respond with full payment, and all current amounts owing have not been paid.

CONCLUSIONS

TECHNOLOGY SERVICES INC failed to provide an annual gross revenue statement and fee payment required by law. TECHNOLOGY SERVICES INC owes the current balance of **\$206.00**.

The amount set forth above should be assessed with the applicable late payment penalty to accrue at 2 percent per month on the balance of the annual fee due until the Commission receives full payment. For a current payment amount, please contact Holly Miley at (971) 239-6280 or holly.miley@puc.oregon.gov. Failure to comply with the terms of this order may result in the Commission suspending or cancelling the telecommunications provider's Certificate of Authority to provide telecommunications service in Oregon.⁵

ORDER

IT IS ORDERED that:

1. TECHNOLOGY SERVICES INC is assessed **\$206.00** immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
2. Where applicable, the late payment penalty will continue to accrue at 2 percent per month until the Commission receives full payment.
3. Under ORS 293.231, the Commission must refer your account to the Department of Revenue or a private collection firm if it receives no payment on the amount due and payable in this Order by the due date of **9/9/2024**, which is ninety days from its 6/5/2024 origination date. Non payment will result in a minimum 20% collection fee added to the amount you owe.
