**ORDER** 

Assessment of OUS Quarterly Payments

## **DISPOSITION: \$276.99 CHARGES ASSESSED**

In this order, the Public Utility Commission of Oregon assesses \$276.99 against Q LINK MOBILE LLC for failure to make required payments. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

### FINDINGS OF FACT

Q LINK MOBILE LLC is a telecommunications provider required to submit quarterly contribution worksheets and payments to the Commission for the Oregon Universal Service Fund (OUSF).<sup>1</sup> These amounts can include any or all of the following: contribution payment(s), late payment penalty(ies), interest and late statement fee(s), including any portion due but not paid for the period(s).<sup>2</sup>

Q LINK MOBILE LLC failed to meet these requirements by failing to pay the Fourth Ouarter of 2024.<sup>3</sup>

The Commission sent a Proposed Order to Q LINK MOBILE LLC on 4/10/2025. Q LINK MOBILE LLC did not respond with full payment, and all current amounts owing have not been paid.

## **CONCLUSIONS**

Q LINK MOBILE LLC failed to meet its filing obligations required by law. Q LINK MOBILE LLC owes the current balance of \$276.99. These charges are for the Fourth Quarter of 2024.

The amount set forth above should be assessed, with the applicable interest to accrue at 9 percent per annum until the Commission receives full contribution payment.<sup>4</sup> For a current payment amount, please contact Laurel Anderson at (971) 375-5059 (laurel.anderson@puc.oregon.gov). Failure to comply with the terms of this order may

result in the Commission suspending or cancelling the telecommunications provider's Certificate of Authority to provide telecommunications service in Oregon.<sup>5</sup>

### **ORDER**

## IT IS ORDERED that:

- 1. Q LINK MOBILE LLC is assessed \$276.99 immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
- 2. Where applicable, interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment.
- 3. Under ORS 293.231, the Commission must refer your account to the Department of Revenue or a private collection firm if it receives no payment on the amount due and payable in this Order by the due date of 7/14/2025, which is ninety days from its 4/10/2025 origination date. Non payment will result in a minimum 20% collection fee added to the amount you owe.
