#### STAFF RECOMMENDATION:

Grant a temporary waiver for Cascade Natural Gas's Renewable Natural Gas Compliance Report, extending the filing deadline from June 30, 2025 to July 31, 2025.

#### **DISCUSSION:**

#### Issue

Whether the Public Utility Commission (Commission) should extend Cascade Natural Gas's (Cascade or the Company) Renewable Natural Gas Compliance Report (the Report) deadline from June 30, 2025 to July 31, 2025.

## Applicable Rule or Law

Senate Bill (SB) 98 (2019) created a renewable natural gas (RNG) program for Oregon gas companies. Participation in this program is governed under the Commission's Division 150 rules. Oregon Administrative Rule (OAR) 860-150-0600(1) states:

A large natural gas utility or a small natural gas utility that participates in the RNG program described in these rules must file an annual compliance report for each year that the utility participates in the program by making RNG purchases or qualified investments. Each compliance report will cover

a calendar year, beginning January 1 through and including December 31. The first report is due on June 30 of the year following the first compliance year, and then annually on June 30 thereafter for as long as the utility continues to participate in the program.

OAR 860-150-0005(4) permits the Commission to waive any of the Division 150 rules for good cause.

#### **Analysis**

## Background

The Commission approved Cascade's participation in the SB 98 RNG program on December 2, 2024.<sup>1</sup> On June 27, 2025, Cascade filed a petition for a one-time waiver of the Company's Report, which was due three days later.

Cascade's petition seeks to extend the filing deadline by one month, from June 30, 2025 to July 31, 2025. In its filing, the Company notes the reporting requirement is new and that this extension would allow Cascade the time needed to properly fulfill the requirements of the RNG Compliance Report.<sup>2</sup>

Staff supports this petition. The Report is new, and a month delay is worth improving the quality of the report. Staff is not aware of any stakeholder concerns regarding the requested extension.

## Conclusion

Staff recommends the Commission approve Cascade's petition to delay filing the Report until July 31, 2025.
