**ORDER** 

**DISPOSITION: \$50.60 CHARGES ASSESSED** 

In this order, the Public Utility Commission of Oregon assesses \$50.60 against DWF ROUND LAKE PARK & UTILITIES LLC for failure to make required payments. The Commission has designated its files on the subject of this matter as the record in this case and makes the following:

## FINDINGS OF FACT

DWF ROUND LAKE PARK & UTILITIES LLC is a regulated water utility required to submit an annual gross revenue fee statement and fee payment to the Commission. DWF ROUND LAKE PARK & UTILITIES LLC failed to submit the annual fee statement and fee payment by the due date of April 1, 2025. <sup>2</sup>

The Commission sent a Proposed Order to DWF ROUND LAKE PARK & UTILITIES LLC on June 17, 2025. DWF ROUND LAKE PARK & UTILITIES LLC did not respond with full payment, and all current amounts owing have not been paid. This amount can include the outstanding annual fee; a late statement fee;<sup>3</sup> and late payment penalty.<sup>4</sup>

## **CONCLUSIONS**

DWF ROUND LAKE PARK & UTILITIES LLC failed to provide an annual gross revenue statement and fee payment required by law. DWF ROUND LAKE PARK &

UTILITIES LLC owes the current balance of \$50.60. These charges are for the annual fee for 2025.

The amount set forth above should be assessed, with the late payment penalty to accrue at 2 percent per month on the balance of the annual fee due until the Commission receives full payment. For a current payment amount, please contact Holly Miley at (971) 239-6280 or holly.miley@puc.oregon.gov.

#### **ORDER**

#### IT IS ORDERED that:

- 1. DWF ROUND LAKE PARK & UTILITIES LLC is assessed \$50.60 immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
- 2. Where applicable, the late payment penalty will continue to accrue at 2 percent per month until the Commission receives full payment.
- 3. Under ORS 293.231, the Commission must refer your account to the Department of Revenue or a private collection firm if it receives no payment on the amount due and payable in this Order by the due date of **9/18/2025**, which is ninety days from its 6/17/2025 origination date. Non payment will result in a minimum 20% collection fee added to the amount you owe.
