**ORDER** 

#### **DISPOSITION: \$100.00 CHARGES ASSESSED**

In this order, the Public Utility Commission of Oregon assesses \$100.00 against IQVENTURES for failure to make required payments. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

## FINDINGS OF FACT

IQVENTURES is a telecommunications provider required to submit quarterly contribution worksheets and payments to the Commission for the Oregon Universal Service Fund (OUSF).<sup>1</sup> These amounts can include any or all of the following: contribution payment(s), late payment penalty(ies), interest and late statement fee(s), including any portion due but not paid for the period(s).<sup>2</sup>

IQVENTURES failed to meet these requirements by failing to file and pay the First Quarter of 2025.<sup>3</sup>

The Commission sent a Proposed Order to IQVENTURES on 7/18/2025. IQVENTURES did not respond with full payment, and all current amounts owing have not been paid.

## **CONCLUSIONS**

IQVENTURES failed to meet its filing obligations required by law. IQVENTURES owes the current balance of \$100.00. These charges are for the First Quarter of 2025.

The amount set forth above should be assessed, with the applicable interest to accrue at 9 percent per annum until the Commission receives full contribution payment.<sup>4</sup> For a

current payment amount, please contact Nicola Peterson at (503) 586-9531 (nicola.peterson@puc.oregon.gov). Failure to comply with the terms of this order may result in the Commission suspending or cancelling the telecommunications provider's Certificate of Authority to provide telecommunications service in Oregon.<sup>5</sup>

#### **ORDER**

### IT IS ORDERED that:

- 1. IQVENTURES is assessed \$100.00 immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
- 2. Where applicable, interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment.
- 3. Under ORS 293.231, the Commission must refer your account to the Department of Revenue or a private collection firm if it receives no payment on the amount due and payable in this Order by the due date of 10/19/2025, which is ninety days from its 7/18/2025 origination date. Non payment will result in a minimum 20% collection fee added to the amount you owe.
