ORDER

DISPOSITION: TIMELINE SPECIFIED IN ORDER NOS. 12-437 and 12-408
AMENDED

On September 12, 2025, Northwest Natural Gas Company, dba NW Natural, filed a motion requesting to amend Order Nos. 12-437 and 12-408. Order Nos. 12-437 and 12-408, establishes the requirement that the amortization period associated with NW Natural's Site Remediation Recovery Mechanism (SRRM) run from November 1 through October 31. The company requests modification of the dates to require the amortization period run from October 31 to October 30. NW Natural explains that the requested change is intended to address House Bill (HB) 3179 (2025), which would amend ORS 757.210(7) to state "[a]ny increase in residential rates may not take effect from November 1 to March 31." NW Natural states that it seeks to permanently modify the amortization period to enable the company to request amortization to align with the recently changed effective date of its annual Purchased Gas Cost rate adjustment filing and ensure these rate adjustments can be implemented on October 31 going forward. No party filed an objection to NW Natural's request.

The Chief Administrative Law Judge has been delegated the authority to modify timelines specified in a Commission order.¹ I find good cause to amend Order Nos. 12-437 and 12-408, to modify the amortization period to address HB 3179, consistent with the amendment to the Purchased Gas Adjustment Guidelines in Order No. 25-308 entered in docket UM 1286, which amends the effective date of the Purchased Gas Adjustment to October 31.

Order Nos. 12-437 and 12-408 are amended to change the requirement that the amortization period associated with NW Natural's SRRM run from November 1 through October 31, to requiring that the amortization period run from October 31 to October 30.
