Authorization of Deferred Accounting for Energy Storage Projects.

STAFF RECOMMENDATION:

Staff recommends the Commission approve Pacific Power's (PacifiCorp or Company) application for reauthorization of deferred accounting for Energy Storage projects docketed as UM 2027(6) for the 12-month period beginning June 17, 2025

DISCUSSION:

Issue

Whether the Commission should approve PacifiCorp's application for deferred accounting for its Energy Storage Projects.

Applicable Law

In accordance with Oregon Revised Statutes (ORS) 757.259 and OAR 860-027-0300, PacifiCorp applied to the Public Utility Commission of Oregon (Commission) for an order authorizing deferral of the costs associated with PacifiCorp's energy storage pilot programs (Deferred Amount).

Analysis

Background

In this application, the Company is requesting reauthorization to defer all costs associated with the energy storage projects for the 12 months beginning June 17, 2025.

Oregon House Bill (HB) 2193 required PacifiCorp to submit to the Commission a proposal to develop energy storage systems and procure any authorized projects by January 1, 2020.

In July 2018, the Company reached a stipulation with the Staff of the Commission and the Oregon Citizen's Utilities Board on the project proposals and evaluation plan. This included two projects:

- Pilot Project #1 involved building a 2 megawatt/6 megawatt-hour battery to meet the requirements of HB 2193.
- Pilot Project #2 is a Community Resiliency Pilot to provide technical and financial assistance to study and deploy energy storage resources to facilities critical to emergency response or disaster recovery.

Proposed Accounting

The Company plans to record the deferral amount as a regulatory asset in FERC Account 182.3 (Other Regulatory Assets), crediting various applicable FERC accounts.

Reasons for Deferral

ORS 757.259(2)(e) allows the deferral of identifiable utility expenses in order to minimize the frequency of rate changes or the fluctuation of rate levels or to match appropriately the costs borne and benefits received by customers.

Description of expenses

The expenses are associated with implementing the energy storage pilot projects approved in Order No. 18-327.

Estimate of Amounts

The Company anticipates it will defer up to approximately \$160,000 over the next 12 months. Pilot Project #1 is a capital project that Staff understands is still in development and delayed several years after recently going through a rebid of the supply contract. Pilot Project #2 has been limited for cost recovery at \$1,800,000, and the Company seeks reauthorization to defer up to that amount.

Staff understands the \$160,000 anticipated for the next 12 months is for one outstanding grant award for Pilot Project #2. Upon award of the outstanding grant, PacifiCorp intends to sunset Pilot Project 2.1

The Company did not recover costs relating to Pilot Project #2 in 2024. The Company requests that, under Order No. 08-263 as modified by Order No. 10-279, be allowed to accrue interest on the unamortized balance, consistent with the treatment of interest rates during accrual and amortization described in those orders. The Company will seek amortization of the deferred amount in future Commission proceedings.

Staff also requested from the Company a detailed cost breakdown regarding previous costs for each calendar year 2020, 2021, 2022, 2023, and 2024.² Staff's review of this information raised no concerns. However, Staff recommends the Company file soon for recovery of some amounts to avoid excessive accumulation of interest charges.

Information Related to Future Amortization

- Earnings Review Staff anticipates determining whether an earnings review is appropriate at the time PacifiCorp seeks to amortize these amounts.
- Prudence Review PacifiCorp will submit Pilot evaluation reports that will
 provide detailed cost summaries. A prudence review can also be performed
 during the Pilots' operations.
- Sharing Does not include a sharing mechanism.
- Rate Spread/Rate Design Applicable costs will be allocated to each schedule
 using the applicable schedule's forecasted energy on the basis of an equal
 percent of revenue applied on a cents-per-kWh basis.
- Three Percent Test (ORS 757.259(6)) The amortization of the Pilot's deferred costs will not be subject to the three percent

Conclusion

Staff concludes that PacifiCorp's request to re-authorize the deferral meets the requirements of ORS 757.259 and OAR 860-027-0300 and is consistent with the Company's initial application for deferral.
