Revise the filing date for Idaho Power Company's next Distribution System

Plan.

STAFF RECOMMENDATION:

Revise the filing date for Idaho Power Company's next Distribution System Plan to on or before July 31, 2026.

DISCUSSION:

Issue

Whether the Oregon Public Utility Commission (Commission) should revise the filing date for Idaho Power Company's (Idaho Power or the Company) next Distribution System Plan (DSP or Plan) from on or before March 6, 2026, to on or before July 31, 2026.

Applicable Rule or Law

ORS 756.040 describes the general powers of the Commission to supervise and regulate every public utility, and to do all things necessary and convenient in the exercise of that authority.

Under ORS 756.105(1), "Every public utility or telecommunications utility shall furnish to the Public Utility Commission all information required by the commission to carry into effect the provisions of ORS chapters 756, 757, 758 and 759."

In Order No. 19-104, the Commission opened Docket No. UM 2005 to "develop a transparent, robust, holistic regulatory planning process for electric utility distribution system operations and investments."

Order No. 20-485 established procedural and substantive DSP planning requirements, as well as the process for Commission review of the Plans.

Order No. 24-421 revised DSP planning requirements and established dates for utilities to file their next DSPs.

Analysis

Background

Idaho Power was initially scheduled to file its DSP on March 21, 2025. Since the establishment of this date, Staff led a process to revise DSP Guidelines in 2024 and invited utilities to propose a new filing date, to be no later than March 31, 2026. Idaho Power proposed March 6, 2026, for its next DSP. Pacific Power selected March 31, 2026, for its next DSP filing through the same process.

Staff believes all parties would benefit from increased spacing between utility filings to allow for more thoughtful review of the Company's Plan. Staff engaged Idaho Power in September to inquire about an alternative filing date. Through that discussion, Staff and the Company identified July 31, 2026, as an acceptable alternative. This would increase the space between filings from approximately three weeks to four months.

Conclusion

Staff believes that revising the filing date for Idaho Power's next DSP to July 31, 2026, will allow more thoughtful review of the Company's Plan by Staff and stakeholders.

PROPOSED COMMISSION MOTION:

Revise the filing date for Idaho Power Company's next Distribution System Plan to on or before July 31, 2026.

Idaho Power filed Part Two of its inaugural plan on August 15, 2022, which the Commission accepted on March 21, 2023. The Guidelines at that time called for utilities to file their next Plans within two years of the Commission Order for Part 2. Idaho Power's next DSP would be due March 21, 2025.
