ORDER

DISPOSITION: \$277.27 CHARGES ASSESSED

In this order, the Public Utility Commission of Oregon assesses **\$277.27** against Q LINK MOBILE LLC for failure to make required payments. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

FINDINGS OF FACT

Q LINK MOBILE LLC is a telecommunications provider required to submit quarterly contribution worksheets and payments to the Commission for the Oregon Universal Service Fund (OUSF).¹ These amounts can include any or all of the following: contribution payment(s), late payment penalty(ies), interest and late statement fee(s), including any portion due but not paid for the period(s).²

Q LINK MOBILE LLC failed to meet these requirements by failing to pay the Second Quarter of 2025.³

The Commission sent a Proposed Order to Q LINK MOBILE LLC on 10/15/2025. Q LINK MOBILE LLC did not respond with full payment, and all current amounts owing have not been paid.

CONCLUSIONS

Q LINK MOBILE LLC failed to meet its filing obligations required by law. Q LINK MOBILE LLC owes the current balance of **\$277.27**. These charges are for the Second Quarter of 2025.

The amount set forth above should be assessed, with the applicable interest to accrue at 9 percent per annum until the Commission receives full contribution payment.⁴ For a current payment amount, please contact Nicola Peterson at (971) 375-2774 (nicola.peterson@puc.oregon.gov). Failure to comply with the terms of this order may result in the Commission suspending or cancelling the telecommunications provider's Certificate of Authority to provide telecommunications service in Oregon.⁵

ORDER

IT IS ORDERED that:

1. Q LINK MOBILE LLC is assessed **\$277.27** immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
2. Where applicable, interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment.
3. Under ORS 293.231, the Commission must refer your account to the Department of Revenue or a private collection firm if it receives no payment on the amount due and payable in this Order by the due date of **1/19/2026**, which is ninety days from its **10/15/2025** origination date. Non payment will result in a minimum 20% collection fee added to the amount you owe.
