ORDER

**DISPOSITION: \$100.00 CHARGES ASSESSED**

In this order, the Public Utility Commission of Oregon assesses **\$100.00** against BUSINESS GROWTH ELITE INC for failure to make required payments. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

**FINDINGS OF FACT**

BUSINESS GROWTH ELITE INC is a telecommunications provider required to submit quarterly contribution worksheets and payments to the Commission for the Oregon Universal Service Fund (OUSF).<sup>1</sup> These amounts can include any or all of the following: contribution payment(s), late payment penalty(ies), interest and late statement fee(s), including any portion due but not paid for the period(s).<sup>2</sup>

BUSINESS GROWTH ELITE INC failed to meet these requirements by failing to pay the Second Quarter of 2025.<sup>3</sup>

The Commission sent a Proposed Order to BUSINESS GROWTH ELITE INC on 10/17/2025. BUSINESS GROWTH ELITE INC did not respond with full payment, and all current amounts owing have not been paid.

**CONCLUSIONS**

BUSINESS GROWTH ELITE INC failed to meet its filing obligations required by law. BUSINESS GROWTH ELITE INC owes the current balance of **\$100.00**. These charges are for the Second Quarter of 2025.

The amount set forth above should be assessed, with the applicable interest to accrue at 9 percent per annum until the Commission receives full contribution payment.<sup>4</sup> For a

current payment amount, please contact Nicola Peterson at (971) 375-2774 ([nicola.peterson@puc.oregon.gov](mailto:nicola.peterson@puc.oregon.gov)). Failure to comply with the terms of this order may result in the Commission suspending or cancelling the telecommunications provider's Certificate of Authority to provide telecommunications service in Oregon.<sup>5</sup>

**ORDER**

IT IS ORDERED that:

1. BUSINESS GROWTH ELITE INC is assessed **\$100.00** immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
2. Where applicable, interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment.
3. Under ORS 293.231, the Commission must refer your account to the Department of Revenue or a private collection firm if it receives no payment on the amount due and payable in this Order by the due date of **1/20/2026**, which is ninety days from its **10/17/2025** origination date. Non payment will result in a minimum 20% collection fee added to the amount you owe.
