ORDER

**DISPOSITION: STIPULATION ADOPTED**

On March 6, 2001, the Public Utility Commission of Oregon filed a complaint against Defendant. The complaint charged Defendant with one violation of law and requested a penalty of \$1,000. On March 13, 2001, a copy of the complaint was served.

On March 21, 2001, the parties to this proceeding entered into a stipulation, which is attached and incorporated by reference.

Defendant admits committing the violation alleged in the complaint. The stipulation is adopted.

From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and Defendant has violated Oregon Administrative Rule(s) as alleged. Pursuant to the provisions of ORS 757.993, penalties should be assessed against Defendant under the terms and conditions of the stipulation.

**ORDER**

IT IS ORDERED that:

1. Civil monetary penalties shall be assessed against Defendant in the amount of \$1,000; and
2. Defendant shall pay the sum of \$500, due and payable within 30 days from the date of service of this order; and
3. Payment of the balance of the penalties (\$500) shall be suspended for a period of one year following entry of this order; and
4. Within 45 days following entry of this Order, Defendant shall arrange for a training session on Oregon excavation laws by contacting the Oregon Utility Notification Center (OUNC) Speakers Bureau.
5. Complainant may reopen this proceeding and petition for imposition of all or a portion of the suspended penalties if Defendant has not complied with all OUNC rules for a period of one year following entry of this order.

11 STIPULATION FOR ENTRY OF FINAL  
12 ORDER

13 The Public Utility Commission of Oregon, appearing by and through Paul A. Graham,  
14 Assistant Attorney General, and Collins & Sons Excavating, the defendant herein, hereby  
15 stipulate as follows:

16 1.

17 A Complaint in this case is pending before the Commission charging the defendant with  
18 one violation of law, as set out in the attached Complaint on file herein.

19 2.

20 Both parties to this proceeding are willing to forego further processing of that Complaint  
21 and further are willing to resolve this matter on the basis of this stipulation.

22 3.

23 The defendant admits that the violation was committed as alleged in the Complaint and is  
24 willing for the Commission to enter an order finding that the violation was committed as alleged  
25 in the Complaint.

2 The parties further agree that the Commission may enter an order assessing civil  
3 monetary penalties against the defendant in the amount of \$1000 under the following terms and  
4 conditions:

5 A. \$500 shall become due and payable on or before the 30th day following the Commission's  
6 entry of a final order in this case. Payment shall be by cashier's check or money order made  
7 out to the Public Utility Commission of Oregon, and the memo line of the cashier's check or  
8 money order shall state the "NC" docket number in the caption of this stipulation. Payment  
9 of the balance of the penalties (\$500) shall be suspended for a period of one year following  
10 the entry of the Commission's final order in this case. If defendant complies with all of the  
11 rules adopted by the Oregon Utility Notification Center (OUNC) under ORS 757.552 for that  
12 one year period, the suspended penalties (\$500) shall be dismissed and no further penalties  
13 shall be imposed for the violation alleged in the Complaint.

14 B. In the event that complainant contends that the defendant has not complied with all OUNC  
15 rules for that one year period, complainant may reopen this proceeding and petition for  
16 imposition of all or a portion of the suspended penalties. In such case defendant shall be  
17 entitled to a hearing and to be notified of the basis upon which complainant contends that  
18 compliance has not occurred.
