DISPOSITION: COMPLIANCE FILING APPROVED

Earlier in this investigation, we directed PacifiCorp, dba Pacific Power and Light Company (PacifiCorp), and other utilities to file revised tariffs and standard contract forms that set forth rates, terms and conditions for Qualifying Facilities. *See* Order No. 06-538. Pursuant to that order, PacifiCorp filed Advice No. 06-019 (Advice filing). To allow Commission Staff (Staff) sufficient time to review the filings, we suspended the filing for investigation at the November 7, 2006, Commission Public Meeting.

On March 2, 2007, Staff reported its finding that PacifiCorp's filing complies with Order No. 06-538. Staff recommended that the Commission approve the filing and request PacifiCorp to issue new tariff sheets and standard contracts with new effective dates. Staff also recommended that, thirty days from the effective date of the revised standard contracts and tariff sheets, PacifiCorp remove the provision "Section 24, Commission Investigation" from the standard contract form. *See* Order No. 05-899.

Staff served a copy of its finding to all parties to this docket and recommended that the Advice filing be allowed to go into effect. The Department of Energy reported to Staff that it found no problem with the Advice filing. No other party has objected to Staff's finding or opposed allowing PacifiCorp's Advice filing to go into effect.

Based on Staff's finding, we conclude that PacifiCorp's Advice No. 06-019 should be approved and allowed to go into effect. With this approval, PacifiCorp should file new tariff sheets and standard contracts with new effective dates. Thirty days after the effective date of the revised standard contracts and tariff sheets, PacifiCorp should remove the contract provision identified by Staff and refile its standard contract form.


ORDER
