DISPOSITION: COMPLIANCE FILING APPROVED

On October 20, 2006, Idaho Power Company (Idaho Power) filed Advice No. 06-10 with a requested effective date of November 20, 2006, pursuant to Order No. 06-538. On November 3, 2006, Idaho Power made a supplemental filing to include an off-system standard contract, previously omitted through a misunderstanding. The supplemental filing also included minor additions to Schedule 85, to reference the on-system and off-system standard contracts and make typographical corrections to the on-system standard contract.

At its public meeting on November 7, 2006, the Commission suspended the filing to provide Staff sufficient time for review. During its investigation Staff identified a limited number of changes to the on-system contract, also applicable to the off-system contract, for full compliance with Order No. 06-538. The changes in part reflected comments Staff received during the review period from the Oregon Department of Energy (ODOE).

On May 11, 2007, Idaho Power made a supplemental filing that incorporates Staff's requested changes and corrects an error in the formula in Section 7.4 for calculating Shortfall Energy repayment prices. On May 16, 2007, Idaho Power filed redlined versions of the standard on- and off-system contracts the company had filed on May 11, 2007. The redlined versions show changes Idaho Power made to the documents filed on November 3, 2006. These changes resolve the issues raised by ODOE.


On May 16, 2007, Staff reported its finding that Idaho Power's amended filing complies with Order No. 06-538. Staff served a copy of its finding on the service list in this proceeding.

Based on Staff's finding, we conclude that Idaho Power's supplement to Advice No. 06-10 should be approved and allowed to go into effect. This order concludes the compliance investigation in Docket UM 1129.


ORDER
