DISPOSITION: ORDER NO. 11-020 CORRECTED;
ADVICE NO. 10-019 ALLOWED

At its December 28, 2010 Public Meeting, the Public Utility Commission of Oregon (Commission) addressed two advice filings made by PacifiCorp, dba Pacific Power (Pacific Power) in docket UE 216. The Commission adopted recommendations by the Commission's Staff to allow both filings—Advice No. 10-019 and Advice No. 10-023—to go into effect. In issuing separate orders to document the decisions, however, the Commission erroneously issued two orders addressing Advice No. 10-023. Accordingly, the first two paragraphs of Order No. 11-020 are corrected to read as follows:

On November 15, 2010, PacifiCorp, dba Pacific Power (Pacific Power) filed Advice No. 10-019 with the Public Utility Commission of Oregon (Commission), updating tariff Schedule 220, Standard Offer Supply Service; Schedule 294, Transition Adjustment; and Schedule 295, Transition Adjustment One-Time Multi-Year Cost of Service Opt-Out, with a proposed effective date of January 1, 2011. A description of the filing and its procedural history is contained in the Staff Report, attached as Appendix A, and incorporated by reference.

At its public meeting on December 28, 2010, the Commission adopted Staff's recommendation, and allowed the Company's Advice No. 10-019 to go into effect as of January 1, 2011.

In addition, the ORDER paragraph is corrected to read:


IT IS ORDERED that Pacific Power's Standard Offer Service and Transition Adjustment Rates are adopted, and the changes to Schedules 220, 294, and 295 are approved, effective January 1, 2011.

The remainder of the order is unchanged.


ORDER

IT IS ORDERED that Order No. 11-020 is modified as described above.

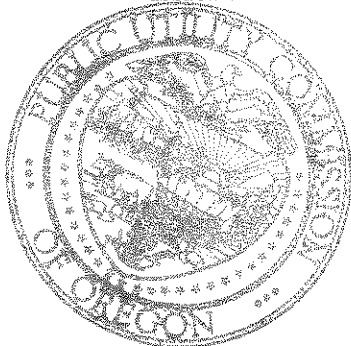
