#### STAFF RECOMMENDATION:

In support of the petition filed by Rio Networks Inc. (Rio Networks), staff recommends that the Commission grant the petition but expressly reserve the authority to revoke the exemption for cause as explained in this Staff report.

# **DISCUSSION:**

On February 6, 2012, Rio Networks filed a petition pursuant to Oregon Administrative Rule (OAR) 860-032-0012(15)(c) requesting exemption from the rule's monthly Service Quality Reporting requirement. Rio Networks is certified as a Competitive Telecommunications Provider in the state of Oregon.

Rio Networks has met all service quality objective service levels as set forth in sections (4) through (8) of OAR 860-032-0012 for the 12 consecutive months ending in December 2011. Staff has reviewed Consumer Services Division archives of complaints relating to Rio Networks and found no complaints within the study period.

Staff notes that granting an exemption request under the rule does not vacate Rio Networks' continuing requirement to measure service quality metrics, gather information and retain a complete record of service quality data for up to one year as outlined in OAR 860-032-0012. Rio Networks' request, if granted, would only exempt Rio Networks from submitting Service Quality Reports to the Commission on a monthly basis. Any exemption from Service Quality Reporting may be revoked upon a showing by Staff that service has degraded, primarily by a resumption of service complaints.

Rio Networks' request for the exemption to cease reporting service quality results be approved subject to revocation upon a showing by Staff that service has degraded.
