Request for approval to initiate a permanent rulemaking for revisions to OTAP benefit amount and to implement revisions to rules for TDAP.

STAFF RECOMMENDATION:

Open a permanent rulemaking docket to consider revisions to the Oregon Telephone Assistance Program (OTAP) benefit amount and to implement revisions to rules for the Telecommunication Devices Access Program (TDAP).

DISCUSSION:

Issue

Whether the Public Utility Commission of Oregon (Commission) should open a permanent rulemaking docket to consider revisions to the OTAP benefit amount and to implement revisions to rules for the TDAP.

Applicable Law

Pursuant to ORS 756.060, the Commission "may adopt and amend reasonable and proper rules and regulations relative to all statutes administered by the commission..." The Oregon Administrative Procedures Act, specifically ORS 183.325 to ORS 183.410, sets forth the process for amendment of administrative rules.

Analysis

Scope of Rulemaking - Oregon Telephone Assistance Program

The Oregon Telephone Assistance Program (OTAP) is a plan of assistance to low-income customers established under Sections 2 and 6, chapter 290, Oregon Laws 1987, as amended, to ensure adequate, affordable residential telecommunication service is available to all citizens and to support broadband internet access service. It is the state counterpart to the Federal Communications Commission's (FCC's) Lifeline program, collectively known as Oregon Lifeline. The OTAP currently provides \$7.00¹ of state Lifeline support from the Residential Service Protection Fund (RSPF) per month in addition to the maximum support of \$9.25 available from the federal Universal Service Fund for voice service² or broadband internet access service or both.

On June 23, 2021, Oregon Governor Kate Brown signed into law House Bill 5032³ that comprises the overall Commission's legislatively adopted budget for the 2021-2023 biennium. The legislatively adopted budget included a package, which the Commission originally submitted in its Agency Request Budget, to adjust the OTAP discount from \$3.50 to \$10.00. The proposed rulemaking is an opportunity for the Commission to revise the level of OTAP support to \$10.00.

Telecommunication Devices Access Program

Pursuant to ORS 759.695, as amended, the Commission, with the advice of the Telecommunication Devices Access Program Advisory Committee, is responsible for:

- (1) Establish[ing] and administer[ing] a statewide program to purchase and distribute assistive telecommunication devices to persons who are deaf, hard of hearing, speech-impaired or deaf-blind and establish a telecommunications relay service.
- (2) [E]stablish[ing] and administer[ing] a statewide program to purchase and distribute adaptive equipment to make telephone service generally available to persons with physical disabilities.

The Commission, in Docket No. AR 635, adopted OAR 860-033-0535(1) that allows for the transfer of assistive telecommunication devices and adaptive equipment

(equipment) ownership to the TDAP recipient four (4) years after the purchase date. However, the current rule does not address transfer of ownership for equipment that the manufacturer has officially discontinued. One of the objectives of the proposed rulemaking is to clarify that equipment officially discontinued becomes property of the TDAP recipient.

Staff anticipates receiving feedback from the public, telecommunications industry, and the OTAP and TDAP advisory committee members. Pending approval to open this rulemaking docket, Staff will schedule a workshop in early August and bring proposed rules for Commission consideration shortly thereafter, in anticipation of a February 1, 2022, effective date for any resulting changes.

Conclusion

Opening a permanent rulemaking docket in Docket No. AR 646 is necessary to respond to the Commission's 2021 Legislatively Adopted Budget that increased the RSPF expenditure limitation to accommodate a \$10.00 monthly OTAP discount rate. Consideration of an amendment to the administrative rule governing TDAP equipment ownership is also necessary for consistency and efficiency of program administration. Any additional issues identified in the informal process will be addressed when Staff brings proposed rules to the Commission for consideration in issuing a notice of proposed rulemaking.
